I think the majority of Centers of Life will be in Greater Portland Area with perhaps more than 3 groups initially. I'm not sure about how to include the Southern Oregon area, Since our area is so large many of us travel hours to attend a meeting and are not located in one local area. Four of the Sisters are now in the Portland area. The other 3 Sisters in this Mission Centre are near the coast, in Medford and in Salem, a long way from everyone else. Almost all active Associates we have had are not able to be active now, have health issues, or have died.

I presume that in many places, where the Mission Centre is a geographic unit where sisters know each other well and have an established pattern of caring about each other, will continue their current patterns of showing up for each other and adapting to each other's changing needs. In Oregon, Mission Centres, may need a revised, geographic organizational pattern. The least disruptive approach could be making locations where Sisters are physically clustered the day-to-day "centers of life" and a named state-wide umbrella as a structure for periodic larger gatherings of Sisters or Sisters and Associates.

In our Yakima Mission Centre, I see the Center of Life evolving from our current Mission Centre. But I would like to see possibilities for "adjunct" members of the Mission Centre who live in other areas but wat to be connected with us and our ministries. There could be two levels of membership: "Main" meaning you live in that MC, and "Supporter" meaning you live elsewhere but want to stay in touch with the MC and contribute whenever possible to activities, e-meetings, etc.

Some will gravitate toward and want to remain with already established resonance group that they feel comfortable with. ("If it ain't broken, we don't need to fix it") Others will be open to new groups that are created and the shy or disconnected will remain outside any groups. There are gifted activators in our community, sensitive and visionary who will inspire new expressions of groups of belonging.

I think that the East Bay and Merrill form natural center locations, but Santa Cruz has become a center as well. Thursday prayer group brings us together, and that core group are involved in Villa activities and the Chapel community. It provides a good mix of caring for one another, spirituality and mission. What we have done only rarely is participate as a group in Province business. I don't know enough about Or, WA and the East Coast to comment.

At this time all is by Zoom. I have been part of small international group for more than five years and two other international groups also.

Many of us are part of other groups, cohorts etc. which can be considered somewhat centres of life. These are sources of enrichment which foster the 4 values above. Sharing this richness with our local centres of life spreads the good news of who we are congregationally. Creates a sense of pride, gratitude and joy.

It is hard for me at this point in my life to separate out my local geographical area (Portland) from Mary's Woods (Lake Oswego). I have visited MW's with some frequency because I walked as a friend and healthcare representative with a Sister through her cancer and 10 months on Hospice. I also attend the community gatherings and celebrations and other opportunities at Mary's Woods. The first three bullet points under Core Values are provided for Sisters living at MW's and often beyond MW's by our SNJM staff, Fr. Berg and the Spiritual Care Department. The three bullet points under Culture of Oneness and parts of the Operational Functions within the Centers of Life are not directly addressed at MWs as I have experienced it. So I envision a Center of Life at MW's but the aspects that are missing will need to be addressed. I want to explain my focus on MW's. It is my hope to move to MW's in the next 1-3 years.

It looks like the physical gathering of "Center of Life" will naturally happen in areas with fewer sisters. Many sisters belong life giving circles of various kinds already, including sisters associates and lay people. Take advantage of what already exits. Our energy is limited.

I live with 3 other sisters in Independent living, and 4 sisters live in the Memory Care Unit. So this community is my primary Life Center. There are about 16 sisters and 25 associates that live in the geographic area of Spokane and Coeur d'Alene. With the larger group, we try to meet at least quarterly. We have not gathered regularly as a small community group, although two of us gather for evening prayer every day. We are going to begin gathering once a week, as a community, to touch base, pray and just visit beginning the first Thursday of Advent. We also eat lunch together, mostly every day. We want to intentionally begin to gather more frequently - and hopefully inviting the sisters in memory care to join us.

In USON Region:

Based on my experience of Mission Centers in former NY province

Anticipate these centers of life will include the same people as the current MC—all have been building community in these groupings for many years

Basically Name changes: while NYP –called "regions" (Prior to 2006); In USON called "Mission Centres" (2006-present); after 2026—renamed "centers of life" 2026—

Over the years they have evolved to include associates and partners. Over the years strong interpersonal bonds have developed. Changes will happen as aging continues and deaths occur. There will also be a need for more "staff support" to assure the infrastructure in the years ahead.

Ideas for next steps: for OR

Have a meeting for all OR sisters: Perhaps agenda could be planned by current MC coordinators with one or more from PLT. Brainstorm configurations that fit our current reality. With assistance of our OR Regional staff we already come together for major feasts as well as for funerals. These facilitate community building.

Perhaps additional activities throughout the year could be scheduled at PH foyer that would be open to everyone. Could be a film, a TED talk; a call to justice action; a Laudato Si activity. Could also be a retreat day or a faith sharing time. These events might stimulate some to be part of follow-up groups on the same theme.

I sense a number of sisters have belonged for years to Wisdom groups and prayer groups and some other affinity groups—those provide some of the connectedness mentioned as a feature for centres of life. I see those continuing.

Do we really need officially defined subgroups in OR or could OR be one centre of life with many and diverse fluid subgroups? A challenge: Centres of life address our "heart" needs. In addition as sisters we need to evolve how to address our "nuts and bolts" infrastructure needs. These involve sustaining and extending the infrastructure with regional staff for our daily living needs as well as managing finances. E.g. transportation when we no longer drive; shopping; availability of services in an emergency—earthquake. major winter storm;
